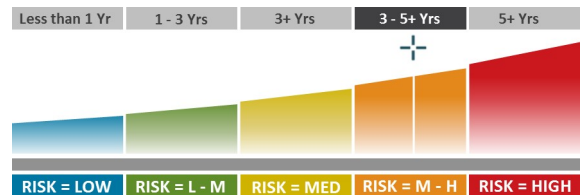

Medium - High Risk
