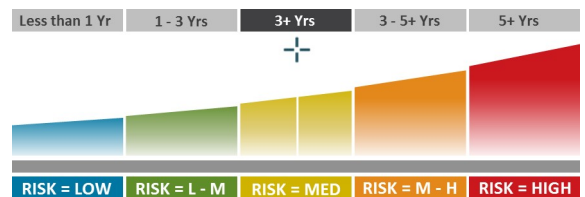

Medium Risk
